ALEMANNO ALBERTO, Prof. Dr., LL.M. (Harvard), LL.M. (Brugge), PhD (Bocconi) Associate Professor of Law, HEC Paris, Attorney-at-Law, New York State Paris

Alberto Alemanno is Jean Monnet Professor of Law at Ecole des Hautes Etudes Commerciales (HEC) Paris and Global Clinical Professor at New York University School of Law. Due to his commitment to bridge the gap between academic research and policy action, he regularly provides advice to a variety of NGOs and governments across the world as well as international organizations, such as the the European Commission, the European Parliament, the Organisation for Economic Cooperation and Development, the World Health Organisation, on various aspects of European Union law, international regulatory cooperation, international trade and global health law as well as evidence-based policymaking. He is the co-founder of TheGoodLobby, an innovative skill-based matching organization connecting people with expertise and knowledge with civil society organizations that need them. Alberto Alemanno was appointed Young Global Leader by the World Economic Forum in 2015. Originally from Italy, Alemanno is a graduate of the College of Europe and Harvard Law School. He holds a PhD in International Law and Economics from Bocconi University. Prior to entering academia fully time, he clerked at the Court of Justice of the European Union, worked as a Teaching Assistant at the College of Europe in Bruges and qualified as an attorney at law in New York. His latest books are Nudge and the Law -A European Perspective (Hart Publishing, 2015 – with Anne-Lise Sibony) and Regulating Lifestyle Risks - Europe, Alcohol, Tobacco and Unhealthy Diets (Cambridge University Press, 2015 - with Amandine Garde). He also published Trade in Food - Regulatory and Judicial Approaches in the EU and the WTO (Cameron May, 2007), Governing Disasters - The Challenges of Emergency Risk Regulation (Edward Elgar, 2011), Better Business Regulation in a Risk Society (Springer, 2013), Foundations of European Food Law & Policy – The First Ten Years of the European Food Safety Authority (Ashgate, 2013). He is the founder and editor of the European Journal of Risk Regulation and runs the Summer Academy in Global Food Law & Policy, the leading training programme for professionals, policymakers and scholars committed to a more sustainable and fairer food supply chain.

BAUDENBACHER CARL, Prof. Dr. h.c. President of the EFTA Court, Director Executive M.B.L.-HSG St.Gallen / Luxembourg

Carl Baudenbacher is the Founder and Director of the Executive M.B.L.-HSG. From 1987 to 2013 he was the Chair of Private, Commercial and Economic Law and the Managing Director of the Institute of European and International Business Law at the University of St. Gallen HSG. In 1995 Baudenbacher was appointed as a Judge of the European Free Trade Association (EFTA) Court. Since 2003 he has been the President of that court. Between 1993 and 2005 Baudenbacher taught European and International Law as a Permanent Visiting Professor at the University of Texas School of Law. From 1994 to 1995 he served as a member of the Supreme Court of the Principality of Liechtenstein. In 2007 he was a member of the Independent Commission of Inquiry for the Investigation of the Events Surrounding the Hypo Group Alpe-Adria established by the Government of the Republic of Austria ("Griss Commission").

Carl Baudenbacher is an experienced legal expert and arbitrator. Besides private clients, he has advised the Swiss Parliament and the Swiss Government as well as the Governments of the Principality of Liechtenstein, the Russian Federation, Israel and the Canton of St.Gallen. His research activities encompass Swiss, European and International business and economic law. Special emphasis lies on the law of EU/EEA fundamental freedoms, unfair competition law, antitrust law, IP law, contract law, company law, labor law, comparative law, law of the globalization and dispute resolution.

# KRONENBERGER VINCENT, Dr.

Legal Secretary at the Court of Justice of the European Union Luxembourg, Luxembourg

Vincent Kronenberger is Legal Secretary (Référendaire) of Advocate General P. Mengozzi at the Court of Justice of the European Union, Luxembourg, since 2006. He joined the Court of Justice in 2003, working with Judge P. Mengozzi at the Court of First Instance of the EC. Prior to joining the Court, he was Officer at the EFTA Surveillance Authority in Brussels, mainly dealing with free movement of capital and freedom of establishment within the EFTA pillar of the EEA, as well as EU company law and consumer law directives extended to the EEA. He also worked as Officer in the European Commission (DG Internal Market), Brussels and as Senior Researcher at the TMC Asser Institute, The Hague. Kronenberger has obtained a doctoral degree in law (Dr.iur.) from the University of Toulouse (France) in 1999. He is also assistant associate professor at the Faculty of Law of the University of Luxembourg since 2010.

MUSGER GOTTFRIED, Hofrat Dr.
Judge at the Supreme Court of Justice of Austria
Vienna, Austria

Having started his judicial career in 1995, Gottfried Musger has been a judge at the Supreme Court of Justice in Vienna since 2006. His main areas of work are intellectual property and unfair competition law. Prior to his appointment as a judge, he had worked as a research assistant at the Universities of Graz and Saarbrücken. From 1997 to 2005 he was a delegate of the Austrian government to working groups of the European Union on questions of international civil procedure (e.g. Brussels I Regulation, Enforcement Title Regulation,

Lugano Convention) and to the Hague Conference on Private International Law (Convention on Choice of Court Agreements).

PASCHALIDIS PASCHALIS, MJur, MPhil, DPhil (Oxon). Référendaire, CJEU Luxembourg, Luxembourg

Paschalis is a référendaire (law clerk) at the chambers of First Advocate General Melchior Wathelet at the Court of Justice of the European Union since November 2012. After completing his bachelor in law at the Aristotle University of Thessaloniki (Greece) he was admitted to read law at the University of Oxford (UK) where he obtained his doctorate in law in 2009. Prior to joining the Court of Justice of the European Union, he worked as an associate in the International Arbitration Group of Shearman & Sterling LLP. He is the author of the book "Freedom of Establishment and Private International Law for Corporations" (OUP, 2012) and other publications in EU law, international arbitration law and Roman law.

## PAULUS CHRISTOPH G., Prof. Dr.

Full Professor for Civil Law, Civil Procedure Law, Insolvency Law and Ancient Legal History, former Dean of the Law School of the Humboldt-University in Berlin Berlin, Germany

Christoph Paulus started his career in 1990 as an Interim Professor for Civil Law and Procedural Law at the universities in Berlin (Technische Universität), Heidelberg and Saarbrücken. Between 1992 and 1994 he has been an Associate Professor for Civil Law and Procedural Law at the University of Augsburg. Afterwards he became a Full Professor for Civil Law, Procedural Law, Insolvency Law and Ancient Legal History at the Humboldt-University in Berlin. From 2004 till 2008 he has been the Dean of International Affairs of the Law School of the Humboldt-University in Berlin. From 2008 till 2010 he has been the Dean of the Law School of that university. In addition to that he is also the Director of the Institute for Interdisciplinary Restructuring (iir). From 2006 to 2012 he acted as the Advisor of the German UNCITRAL delegation for its Working Group V. Furthermore Paulus acted repeatedly as consultant both for the International Monetary Fund and the World Bank. He also had appointments for guest professorships at several universities such as Brooklyn Law School (New York, USA), Universita Commerciale Luigi "Bocconi" (Milan, Italy), University of the Western Cape (Cape Town, South Africa), Izmir University of Economics (Izmir, Turkey), University of Sydney (Sydney, Australia) and Université Panthéon-Assas (Paris, France). In addition to that he is an external faculty member of the MBA program at University of St. Gallen HSG, Switzerland. From 2001 till 2009 he has been the District President of the German-American Lawyers' Association in Berlin. He is also the editor of various periodicals, for example "ZIP" (Zeitschrift für Wirtschaftsrecht) and "IILR" (International Insolvency Law Review).

POHJANKOSKI PEKKA Référendaire, CJEU Luxembourg, Luxembourg

Pekka Pohjankoski is a Legal Secretary (référendaire) at the Court of Justice of the European Union. Previously he worked at the Legal Service of the Ministry for Foreign Affairs of Finland, EU Litigation Unit. Mr Pohjankoski is a graduate of University of Helsinki Law School (Mag. iur.), Harvard Law School (LL.M.) and he has also studied at the Sorbonne Law School (Université Paris I Panthéon-Sorbonne). He is a member of the New York State Bar. His areas of expertise include, in particular, EU law, constitutional law and private international law.

#### SARMIENTO DANIEL, Prof. Dr.

Professor of EU and Administrative Law, Universidad Complutense; Consultant, Uría Menéndez, Madrid Madrid, Spain

Daniel Sarmiento is counsel in the Madrid office. He joined the firm in 2015 as a consultant. His practice areas are European Union law and Spanish public law. He has also been a tenured lecturer on administrative and European Union law at the Universidad Complutense de Madrid since 2010. He has extensive experience in the public sector, having worked for the Spanish Central Administration (2004-2006) and as a legal secretary in the Court of Justice of the European Union (2007-2015). His practice in European Union law covers a wide range of areas, such as competition, state aids, banking law, regulatory, litigation, constitutional law, private international law, tax law, criminal law and institutional affairs. He is the author of several books, including El Control de Proporcionalidad de la Actividad Administrativa ("The Proportionality Assessment of Administrative Action", Tirant lo Blanch, 2004), Poder Judicial e Integración Europea ("The Judiciary and European Integration", Thomson-Civitas, 2004) and El Soft Law Administrativo ("Administrative Soft Law", Thomson-Civitas, 2008). He regularly contributes to reputed legal journals such as the Common Market Law Review, the European Law Review or the Revista Española de Derecho Europeo. He is a member of the executive committee of the Asociación Española para el Estudio del Derecho Europeo (Spanish Association for the Study of European Law), a fellow of the European Law Institute and a member of the editorial board of the Revista de Derecho Comunitario Europeo. Since 2010, he has coordinated the Global Judicial Forum at the Center for European Studies of IE University.

#### **SGUEO GIANLUCA**

New York University Global Professor at NYU-Florence; Professor at Vrije University, Brussels; Policy Analyst at European Parliament Bruxelles

Gianluca Sgueo (PhD in Administrative Law; MA in European Law) is New York University Global Professor at NYU-Florence, where he teaches "Media, Activism and Democracy", and Professor in "Global Advocacy" at Vrije University, in Brussels. Since 2011 he is research associate at the Center of Social Studies of the University of Coimbra, in Portugal. His last book, 'Beyond Networks - Interlocutory Coalitions Between the European and Global Legal Orders', was published by Springer in 2016.

Gianluca Sgueo holds the position of Department Director of the area "Institutions" at I-Com (Institute for competitiveness) – a think tank devoted to economic and social analysis. As Department Director he has coordinated researches on lobbying regulation, transparency and accountability of the public sector.

He is Faculty Member in the Master Program on "Public Affairs and Communication" (Sole24Ore), Scientific Director of the Master Degree in "Economics and Management of the Non-Profit Sector" (Sole24Ore) and Coordinator of the module on "Participation in Politics" of the School of Politics of LUISS School of Government and Sole24Ore. His professional background includes several experiences in the public sector. Since 2014 he is nominated policy analyst at the European Parliamentary Research Service, in Bruxelles. For the European Parliament he has authored reports on lobbying transparency, civil society organizations accountability and contrast to fraud and corruption. In 2011-2013 he served as Head of Communication of the Italian Government.
